

The Council for the Built Environment (CBE) is a statutory body established under the Council for the Built Environment Act No. 43 of 2000. It is a Schedule 3A Entity of the Department of Public Works and an overarching body that coordinates the six councils for the built environment professions (Architecture, Engineering, Landscape Architecture, Project and Construction Management, Property Valuation and Quantity Surveying) for the purpose of promoting good conduct within the professions, transforming the professions and advising the South African government on built environment related issues.

APPLICATIONS ARE INVITED FROM SUITABLY QUALIFIED AND EXPERIENCED INDIVIDUALS TO SERVE AS EXTERNAL MEMBERS ON THE CBE'S AUDIT AND RISK COMMITTEE, ESTABLISHED IN TERMS OF THE PUBLIC FINANCE MANAGEMENT ACT, 1999 (PFMA) AND NATIONAL TREASURY REGULATIONS.

The applicant should have at least a Bachelor's degree and more than ten (10) years senior management experience in one or more of the following fields: Auditing (internal and external), Accounting, Risk Management, Financial Management and Performance Management preferably in the public sector. Registration as CIA, CISA, or CA in good standing with the relevant regulatory body and knowledge of the built environment will be added advantages.

Due to the nature of the appointment, applicants should demonstrate leadership qualities, integrity, independence, dedication and understanding of public sector entities and should possess good communication skills, analytical ability and independent judgement.

The Audit and Risk Committee (ARC) carries out its responsibilities as legislated by the PFMA and National Treasury Regulations, and operates in terms of an approved Charter and a Combined Assurance Model Framework. The ARC fulfils an oversight role to ensure proper financial and risk management, performance evaluation, governance, legal compliance and oversees the internal and external auditing function.



The ARC meets at least four times per year and reports quarterly and annually to the Accounting Authority (the CBE Council).

Successful applicants will be remunerated in accordance with the requirements of National Treasury Regulations and SAICA/AGSA tariffs. Appointments will be for a period of three (3) years renewable to a maximum of six (6) years.

Applications must be accompanied by an updated curriculum vitae, and certified copies of ID documents and qualifications.
