

## Maximising information technology





## THE INTEGRATED ELECTRONIC BUILT ENVIRONMENT SYSTEM (IEBES)

onsultation and a feasibility study to improve the oversight provided by the CBE identified the Integrated Electronic Built Environment System (IEBES) as a solution to address the current challenges, and ensure the CBE meets its strategic goals and improves on reporting. This system will align CBE's oversight of the Councils of the Built Environment Professions (CBEP).

#### The IEBES in motion

- 1. Each CBEP will have their own interface to perform their normal operational activities
- 2. The system will be centralised
- 3. Business Intelligence is built into the system to generate reports and analytics
- 4. Accessibility through security measures ensures the integrity of the system



#### **Benefits**

The fully functional IEBES will improve the CBEP' business models, assist the CBE to exercise oversight efficiently and improve on reporting to the Department of Public Works and other stakeholders. Built-in benefits are timely, complete and accurate data for monitoring and evaluating programme activities in the built environment.

### **Maximising information technology (continued)**

The IEBES will benefit the CBEP greatly, as it will be custom made for their processes. In addition to access to a central database, it allows for changes as and when required for each of the CBEP. The registration process is also included in the system's functionality. The CBEP will eliminate their current dependency on non-standardised systems over which they have no control. The CBE will own the system's Intellectual Property (IP) upon completion, thus minimising anticipated challenges.

The financial benefit for the CBEP is that the CBE bears the full cost of developing and rolling out the system.

#### **SHARED IT SERVICES**

The CBE understands and values the benefit of partnerships with stakeholders to implement its strategic objectives successfully in the built environment. Hence, an IT Forum exists with the CBEP for information sharing and addressing challenges. Currently, Memoranda of Understanding (MoUs) with two CBEP are in place for shared IT services. The CBE's KMIT unit assists them with their IT requirements and provide advisory services. These partnerships have yielded many benefits for the two CBEP such as:

- Compiling specifications for infrastructure procurement
- IT infrastructure setup and host
- IT user support
- Sharing IT network services with CBE


#### **KNOWLEDGE MANAGEMENT**

Plans are afoot for CBE to make knowledge on the built environment available to stakeholders through an online portal (an e-library of sorts). It will store and avail information accumulated through published research, pilot projects, local and international partnerships, and sector-wide trends. The Knowledge Management e-portal platform will make this information available to anyone who has an interest in the built environment – from students to bodies such as the Centre for Academic Research in the Built Environment (CARINBE) based at the University of Johannesburg, the six CBEP and the public.

The Knowledge Management e-platform aims to connect built environment content with people by identifying, creating, storing, sharing and using the knowledge for learning and addressing challenges in the built environment sector.

#### **Looking into the future**

The CBE is developing a digital strategy to align with Industrial Revolution 4.0, with plans to move into the automated environment. Another focus is on reducing the Capital Expenditure (CAPEX) cost, while maintaining Operational Expenditure (OPEX) costs and maximising benefit from resources. The modernisation will focus on digital transformation to improve performance of the organisation. The following illustration explains this:

#### **Dear Valued Industry Stakeholder**

#### **CATEGORIES OF REGISTRATION AND PRESCRIBED COMPETENCIES**

he SACPCMP is one of the six (6) Councils for the Built Environment Professions (CBEP) established by Acts of Parliament - in the case of the SACPCMP, this is through Act No 48 of 2000.

What is synonymous with each of these CBEP is that Section 18 of the Act prescribes the categories of Registration that reside under the ambit of each of these CBEP. Section 18(1)(a) of the SACPCMP Act prescribes the professional categories of registration as being that of a Professional Construction Project Manager (PrCPM) and Professional Construction Manager (PrCM). Section 18(1)(c) of the same Act also gives Council the powers to register Specified Categories it may prescribe from time to time. Currently, SACPCMP registers persons in the following Specified Categories:

- Professional Construction Mentor (PrCmentor)
- Construction Mentor (CMentor)
- Professional Construction Health and Safety Agent (PrCHSA)
- Construction Health and Safety Manager (CHSM)
- Construction Health and Safety Officer (CHSO)

The SACPCMP would like to provide clarity on the specification of the registered persons to be appointed to provide services in the built environment, and the relative merits of specifying professionals registered in the categories of registration that reside within the ambit of this Council.

The SACPCMP seeks to rectify the situation whereby clients/construction employers prescribe disciplines and categories of registered persons to undertake work related to the disciplines under the SACPCMP whilst registered incorrectly – with a Council that is not the custodian of the profession. It is unclear whether this is deliberate and on purpose; however the SACPCMP firmly believes this runs contrary to the spirit and intent of the legislation, hence it needs to be corrected. To illustrate, SACPCMP received several queries where adverts for positions of PrCPM or PrCHSA ask for registration with a CBEP other than the SACPCMP. Seeing as the competencies fall under the domain of the SACPCMP, they should rightfully require registration with the SACPCMP as true custodian of the profession whose services are sought.

While clients and employers are at liberty to prescribe the registration discipline and category for which they will appoint service providers and employ professionals, their preference for that discipline and category should be guided by the competencies and skills of the professional in relation to the needs of the assignment or job. It is therefore prudent to specify disciplines whose services are sought by prescribing that they be registered with the CBEP who is the custodian of that registration category.

## **SACPCMP Registration (continued)**

As stated earlier, each of the CBEP has prescribed categories of registration for its professionals, together with standards to ensure that these professionals meet the competencies required for a particular category. In the case of categories of registration that reside within the SACPCMP, it ensures that persons registered in any of its registration categories are indeed competent to, amongst others, manage the process of planning, management and supervision of projects within the built environment, including the co-ordination, administration and management of resources. The code of conduct protects the public if a registered person is appointed to carry out these duties, and the Council is obliged to investigate any reported case of improper conduct against a registered person.

While registered persons may come from various backgrounds in the built environment such as construction management, engineering, architecture and quantity surveying, the process of registration with the SACPCMP is specifically designed to ensure that registered persons are competent to manage projects, through a rigorous assessment for professional competency.

The SACPCMP would therefore like to advise that any calls for service providers or applications for employment that involve the disciplines outlined above should call for them to be rightfully registered with the SACPCMP. To do otherwise or circumvent this would have the effect of precluding qualified and competent persons from providing such needed services, and might be deemed as an unfair or anti-competitive practice.
