## CBE's role towards building the country of our dreams

Indeed, different efforts and activities were undertaken to promote sector collaboration during the month of July that reflects the aforementioned. As expected in every quarter, the industry and sector stakeholders were brought together to recalibrate the built environment sector. Our Deputy Minister, Honourable Noxolo Kiviet delivered a keynote address focusing on the imbalances and equity as we deliver on national priority areas. Also, what was exciting was to see the great work

done by the Transformation Collaborative Committees (TCCs) being institutionalised through progress reports on their committee deliverables by the Chairpersons as a drive for transformation in the built environment.

Furthermore, in answering the call, I was able to engage with the Western Cape Provincial Government's Head of the Department of Transport and Public Works and the Strategy, Planning and Coordination Manager to help identify areas of collaboration, mutual learning, partnership in relation to professional development, mentorship, and the structured candidacy programme.

In continuing to foster relations with our sister entity, I was able to attend the Construction Industry Development Board's 12<sup>th</sup> Postgraduate Conference in East London, under the theme *"Towards a sustainable construction industry: the role of innovation and digitalisation".* The objective of the conference was to assist the cidb to create an innovative and digitalised industry needed for a more sustainable construction industry. I could not help but think of how the construction industry was initially declining between 2017 and 2020, compounded with the pandemic induced crash due to hard lockdowns. This initiative is one of the key solutions to the slow recovering industry.

To help realise the required change to build the country of our dreams, I believe that the professionalisation of the built environment in the public sector plays an integral role. To that effect, Myself, Advocate Toto Fiduli and Mr Butcher Matutle (Registrars of SACAP and SACPCMP respectively) signed a Memorandum of Collaboration (MoC) with the National School of Government (NSG) represented by the Principal, Professor Busani Ngcaweni. The MoC provides a framework for collaboration and a working relationship between the CBE and NSG to establish and maintain collaborative efforts aimed at enhancing the image of the Built Environment and professionalisation of the public service through promotion of good standards, advocating for professionally registered persons, and protecting the interest of the public.

In this journey there are obstacles and mountains that each of us must overcome, however uncomfortable or difficult. The main lesson learnt is to be honest in all dealings, be true to your country's endeavours to build the country of dreams and the memory of what Nelson Mandela stood for – **forgiveness**.
